


How to get started:

Best Buy Health Broker Affiliate Program






Through this program, you can refer clients to Best Buy Health's PERS solution and earn \$25 for every eligible referral.

Set up your account and get started

These steps must be completed before you join the Best Buy Health Broker Affiliate program.

Create your Broker Affiliate program account

Our Broker Affiliate Program is hosted on CJ Affiliate, a platform that helps us partner with brokers and pay them commissions.

- Click this <u>link</u> and complete the form under "CJ Affiliate Publisher Sign Up."
- Use your business email and create a password
- Click the link in the confirmation email to verify your address

It only takes a few minutes to register. In the CJ system, you'll be referred to as a publisher. This simply means you're a referral partner.



Complete the onboarding checklist

- · Log in to your account
- Validate your email
- · Enter your user information
- · Complete your network profile

Join the Best Buy Health Affiliate Program

- · Log into your dashboard
- Search for Lively (the advertiser name for Best Buy Health)
- · Click "Apply to Program."

Applications are typically reviewed within 24-48 hours. If you don't see Lively, try logging out and back in after completing your property setup.



Access your referral link and tools

Once your application is approved, you can access your referral links by:

- Going to Content > Assets > Links
- · Choosing the "Broker Affiliate Link" campaign to promote
- · Copying your personalized link



Set up your payment method

- In your dashboard, navigate to Settings > Payouts
- Select your preferred payment method (e.g., bank transfer or PayPal)
- Payments are sent monthly with no minimum threshold and are paid directly through CJ

Who should you refer?

- Clients without emergency response coverage through their Medicare Advantage plan
- · Clients who have lost this benefit or never had it
- Clients open to self-pay solutions like PERS or senior-focused mobile phones
